This Fourth Supplementary Base Prospectus (the "**Fourth Supplement**") to the Base Prospectus (the "**Original Base Prospectus**") dated 27 April 2022 (together with the First Supplementary Base Prospectus dated 6 May 2022, the Second Supplementary Base Prospectus dated 17 June 2022 and the Third Supplementary Base Prospectus dated 12 July 2022, the "**Base Prospectus**") is prepared in connection with the Euro Medium Term Note Programme established by DNB Bank ASA (the "**Issuer**" or the "**Bank**"). This Fourth Supplement constitutes a supplementary prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129, as amended (the "**Prospectus Regulation**"). Terms defined in the Base Prospectus have the same meaning when used in this Fourth Supplement.

This Fourth Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus and any other supplements to the Base Prospectus issued by the Bank.

This Fourth Supplement has been approved by the Central Bank of Ireland, as competent authority under the Prospectus Regulation. The Central Bank of Ireland only approves this Fourth Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer or of the quality of the Notes that are the subject of the Base Prospectus (as supplemented). Investors should make their own assessment as to the suitability of investing in the Notes.

The Bank accepts responsibility for the information contained in this Fourth Supplement. To the best of the knowledge of the Bank the information contained in this Fourth Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Purpose of this Fourth Supplement

The purpose of this Fourth Supplement is: to incorporate by reference the unaudited consolidated and non-consolidated interim financial statements of the Bank for the three-month and nine-month periods ended 30 September 2022, which are contained in the document entitled "Third quarter report 2022" (the "**Issuer's Q3 Report**"); and (b) to include a new "Material Change" statement.

Issuer's Q3 Report

On 20 October 2022, the Bank published the Issuer's Q3 Report. The Issuer's Q3 Report has been filed with the Central Bank of Ireland and, by virtue of this Fourth Supplement, the unaudited consolidated and non-consolidated interim financial statements of the Bank for the three-month and nine-month periods ended 30 September 2022 which are contained in the Issuer's Q3 Report are incorporated in, and form part of, the Base Prospectus.

Copies of documents incorporated by reference in this Fourth Supplement can be obtained upon request, free of charge, from the registered office of the Bank and the specified office of the Paying Agent for the time being in London.

Any non-incorporated parts of the "Third quarter report 2022" are either not relevant for an investor or are covered elsewhere in the Base Prospectus."

Material Change

The paragraph under the heading "*Material Change*" on page 242 of the Base Prospectus shall be deemed deleted and replaced with the following:

"There has been no material adverse change in the prospects of the Issuer since 31 December 2021, and there has been no significant change in the financial position or financial performance of the Issuer or the DNB Group since 30 September 2022."

General Information

To the extent that there is any inconsistency between (a) any statement in this Fourth Supplement and (b) any other statement in, or incorporated by reference into, the Base Prospectus, the statements in (a) above will prevail.

Save as disclosed in this Fourth Supplement, there has been no other significant new factor, material mistake or material inaccuracy relating to information included in the Base Prospectus which is capable of affecting the assessment of any Notes or any change in the condition of the Issuer which is material in the context of the Programme or the issue of any Notes since the publication of the Base Prospectus.
